ALBANY COUNTY INDUSTRIAL DEVELOPMENT AGENCY Financial Statement Narrative For the Period Ending November 30, 2025

This report provides an overview of the P&L and Balance Sheet for the Albany County Industrial Development Agency for YTD November 30, 2025.

The Albany County IDA is committed to fostering economic growth and development in the region by promoting industrial projects and supporting businesses.

The IDA's financial performance remains robust and can be attributed to successful project implementation and prudent financial management. The agency's commitment to sound fiscal policies and investments has contributed to the positive financial outcomes.

Total revenue YTD is \$443,016 of which \$334,350 were fees collected including a modification fee of \$1,500 from Plug Power, \$1,500 application fee from Catemer Inc., \$7,500 from CHPE and \$323,850 from Atlas Copco. \$108,666 is interest earned through November 30th. Our current cash position is strong at \$4,584,897. Expenditures YTD were \$292,811. Our change in net position YTD is \$150,205.

The agency invested approximately \$3.5 million in Treasury Bills in the month of November. There is one CD that matured at the end of the month and will be deposited into the operating accounts to use for anticipated expenses that the agency projecting to occur during the first quarter of 2026.

The IDA will continue to invest in key projects with private companies aimed at creating employment opportunities and fostering economic development. These initiatives will generate positive economic externalities and contribute to the long-term viability of the region. Going forward, Camoin Associates will produce an economic impact report for all projects to be presented to the board.

Looking ahead, the IDA is poised for continued success, with a robust pipeline of projects and a strategic vision for sustainable development. The agency will remain adaptive to economic trends, regulatory changes, and industry dynamics to ensure its relevance and effectiveness in the years to come.

Funds will be deposited into the operating accounts to use for anticipated expenses that the agency projecting to occur during the first quarter of 2026.

Prepaid expense balance of \$5,685 is comprised of an insurance payment to Aurora for the time period of November 2025 to September 2026 and CEG Membership for the time period of April 2025 to March 2026.

Plug Power wins NASA contract

Plug Power will supply liquid hydrogen to the National Aeronautics and Space Administration under a recently awarded contract that starts Monday.

The Slingerlands-based manufacturer and hydrogen producer will provide as much as 480,000 pounds of the liquid fuel to the U.S. space agency's Glenn Research Center in Cleveland, Ohio, and the Neil A. Armstrong Test Facility in Sandusky, Ohio.

"By winning this award, Plug is entering the growing space industry which represents a large opportunity for liquid hydrogen in the coming years," the company said in an announcement.

The multiyear commitment from NASA is worth up to \$2.8 million. It entails a two-year initial term plus three one-year options, according to an announcement from NASA, which uses the fuel in cryogenic rocket engines.

"Being selected by NASA for this supply contract is tremendous validation of Plug's ability to deliver low-carbon, high-purity hydrogen where reliability matters most," José Luis Crespo, president and chief revenue officer of Plug, said in a statement. "NASA consumes more than 37 million pounds of liquid hydrogen each year, so this award represents an important first step in what we hope will become a long-term, expanding partnership."

Crespo will become Plug's CEO next year.

Plug (Nasdaq: PLUG) will use its own transportation fleet to deliver the hydrogen, the company said.

Hydrogen production and supply remain a key pillar of Plug's business, though it recently backed off plans to continue building out a network of its own plants after securing what was described as a favorable deal with a third-party supplier. The firm currently operates hydrogen facilities in Georgia, Tennessee, and Louisiana that are capable of making 40 tons of the fuel per day.

Plug delivers hydrogen to companies that use the firm's fuel cell systems to power forklifts in distribution centers.

Plug competitor Air Products and Chemicals Inc. also won a supply contract with NASA – a far larger one. The Pennsylvania-based company will deliver as much as 36.5 million pounds to four sites for a maximum contract value of \$144.4 million, according to the federal agency.
